

General Terms & Conditions governing Pre-Departure COVID-19 In-Clinic Tests

- Offer is only valid for registered users on HealthPass by OCBC (hereinafter referred to as “**HealthPass**”), who will be entitled to OCBC Cardholder’s rates for COVID-19 In-Clinic Swab Test and COVID-19 In-Clinic Swab and Serology Test available on HealthPass (the “**Offer**”).
- The Offer includes:
 - 1 x Swab Test at a Healthway Medical Group clinic at S\$135, with the Swab Test report made available to user.
 - 1 x Swab Test and Serology Test (for China travellers) at a Healthway Medical Group clinic within the same visit at S\$180, with the Swab Test and Serology Test reports made available to user.
 - All prices are exclusive of GST.
